Les Myatt present the Placenta report highlighting the changes that occurred this year, including the appointment of a new Editor (Gernot Desoye) and the transition to new publishers and electronic submission and review of manuscripts. The Journal continues to maintain its Impact Factor and has an acceptance rate of 57%. Les thanked all who support the activities of the Journal.

Kathleen Shiverick presented the Trophoblast Research Report.
